**Eligible Wrestlers:** Must be enrolled in 6th, 7th, or 8th grade  
Grade verification (report card or official letter from school authority) will be required for all wrestlers.

**Weight Classes:** 75, 80, 85, 90, 95, 102, 110, 117, 125, 132, 140, 150, 160, 175, 195, 220, 275

**Team Selection Criteria:**

1. Best 2 wrestlers at weight based on wrestle-offs
2. Representation from all 5 TX-USA regions
3. Fill teams (weight classes) based on available, eligible wrestlers

**Cost:**

To be determined. We are working on funding and sponsoring, but the cost to each wrestler in the past has been approximately \$400. The final cost will cover everything related to the trip including bus to/from Dallas, room, meals and equipment package (singlet, hoodie, t-shirt).
